May 19, 2009

Mayor Seagraves welcomed everyone in attendance for the "Youth-In-Government" Regular Council Meeting, and stated this is the 33rd Annual "Youth-In-Government" Council Meeting. Mayor Seagraves thanked Tim Hopkins, Brookville Schools Superintendent, Mark Brown and Mike Hetrick, Brookville High School Government Teachers, Chris Bronner, Brookville High School Principal, Brookville School Board, Brookville City Officials and employees for making this program such a great success.

Mayor Seagraves introduced Brookville City Council and City Department Heads. Members Cantrell, Duncan, Garber, Letner, Reel and Ullery; Manager Wright, Assistant Manager Sewert, Law Director Stephan, Fire Chief Nickel, Police Chief Preston and Director of Finance/Clerk Keaton were present.

Mayor Seagraves introduced the "Youth-In-Government" Council Members, Department Heads and Mayor. Each received a Certificate of Merit for their participation as they assumed their positions from the regular officials.

The Regular Meeting of the Brookville City Council was called to order by Mayor Lindsey Baker at 7:05 p.m. on May 19, 2009 in the Brookville High School Auditorium. The Pledge of Allegiance was recited.

Motion by Duncan, second by Reel to accept the Agenda as presented. All yeas, motion carried.

Motion by Ullery, second by Cantrell to accept the May 5, 2009 Regular Meeting Minutes as presented. All yeas, motion carried.

Citizens Comments, David Monnin, President of Park Board, reported Park Board was recently approached by Rob Scott, President/CEO of the Dayton Tea Party, Inc., who requested Park Board approval to hold a Tea Party on July 3, 2009 at Golden Gate Park for approximately two hours followed by a fireworks display. The Dayton Tea Party is a grassroots and nonpartisan group opposed to wasteful government spending. The Dayton Tea Party Rally seeks to protest runaway spending at all government levels. The event may possibly attract 8,000 people from throughout the Miami Valley. President Monnin reported Park Board granted approval for the event to be held on July 3 and wanted Brookville City Council to be aware of the event and request their approval.

The "Youth-In-Government" Manager Blake Newssock gave his report with the following action taken.

Motion by Ullery, second by Cantrell to set the dates of June 11, 12 and 13, 2009 for the first annual Community Garage Sale in conjunction with the Brookville Chamber of Commerce Downtown Block Party. All yeas, motion carried.

The "Youth-In-Government" Assistant Manager Mehgan Copenhaver gave her report with no action taken.

The "Youth-In-Government" Fire Chief Joseph Miller had no report.

The "Youth-In-Government" Police Chief Michael Day gave his report with no action taken.

The "Youth-In-Government" Law Director Douglas Roberts gave his report with no action taken.

The "Youth-In-Government" Finance Director/Clerk Katelyn Williams gave her report with the following action taken.

Motion by Reel, second by Ullery to transfer \$25,000 from the General Fund to the Park Fund and \$100,000 from the General Fund to the Street M&R Fund as appropriated and requested by Finance Director/Clerk Keaton. All yeas, motion carried.

The “Youth-In-Government” Mayor Lindsey Baker gave her report with no action taken.

There was no Old Business.

Motion by Garber, second by Letner to adjourn. All yeas, motion carried.
